Summary of the objects of the charity set out in its governing document

Restoration and maintenance of the Bishops Waltham North Pond

The trustees have had regard to the guidance issued by the commission on public benefit. By continuing to carry out our objectives the North Pond Conservation Group is continuing to provide the public benefit that it was set up to do. These objectives are:

- Initial restoration, improvement and ongoing maintenance of the North Pond
- Enhancement of the conservation area for plants and wildlife
- Enhancement of the visual amenity for the benefit of the parish
- Involvement of local people and organisations in the restoration and conservation
- Collaboration with the management of the South Pond

In a Market Town survey, organised by the Bishops Waltham Parish Council in 2008, the general public identified the North Pond as the number one concern in the environmental category. The North Pond Conservation Group was set up to address this concern. Initially set up as a local organisation it received Charitable status in March 2014, when it took on ownership of two thirds of the North Pond and became a Charitable Incorporated Organisation (CIO).

The North Pond Conservation Group gets frequent unsolicited praise from the general public on what it is achieving. We also have an active band of volunteers from the local population who take part in our work parties and gain benefit from seeing the results of their actions and involvement in the community.

The Conservation Group received an 'Action for Market Towns' award in 2013 for its activities and in 2015 won the Group category of the Parish Council's Volunteer Awards.

The outstanding major activity is to retain an area of permanent water when the pond dries up annually. This will address a major concern of the general public that there is no water in the pond for 6 to 8 months each year. It also addresses the distress caused to the general public when dead and dying fish are seen and water birds and their chicks are stranded when the water disappears. Planning consent has been obtained to do the work. Funds need to be secured through grants and donations to carry out the work.

This "All Year Water" project will be a major activity in the next financial year with the aim of completing it in October 2016.

Contributions by volunteers fall into two categories:

This years contribution equated to approximately the same number of hours as in the previous financial year.

Estimated contribution of volunteers was approximately:

- 300 hours of administration and running the charity
 - the major activities were organising work parties, preparation and presentation of the biannual public meetings and activities for the "All Year Water" project, as well as general running and administration
- 600 hours of work party volunteers
 - the weekly autumn/winter and adhoc summer Saturday morning work parties are well attended and this is where the work is carried out to achieve the objectives of the North Pond conservation group

Using a minimum wage assumption this effort equates to approximately £6,000

We hold £20,000 from the Duke's donation as restricted funds to cover the next 25 years pond maintenance. This was a specific donation for this purpose. We are also creating a reserve for funds for the "All Year Water" project which includes £5,000 from the Dukes' donation plus other contributing funds. There will be a major push in the next financial year to increase this reserve so that the project can be undertaken.

Our main source of funds when the charity was set up was a donation of £25,000 by James Duke & Son Ltd. They owned a portion of the pond together with Winchester City Council and Hampshire County Council. The ownership of the Duke's portion of the pond has been transferred to the BWNPCG charity with the donation.

We also apply for grants and look for donations to cover specific projects.

Our next main project is "All Year Water" which aims to remove silt from the south end of the pond to retain year round water. This will enable fish rescue and protect the water birds and other wildlife when the pond dries up. It will also greatly improve the visual amenity for the general public.
